

Ice N Easy Club Support Program Terms & Conditions

What is the Ice N Easy Club Support Program

1. The purpose of the program is to establish a relationship between Ice N Easy and community sporting clubs across Australia.
2. Clubs are encouraged to register for the program to establish a coupon code for their members to enter at checkout.
3. Clubs that are registered will receive 15% from every order using their coupon code.

How to Register

4. Club committee members are encouraged to be the delegate to complete the registration
 - a. In the event a club member completes the registration form, Ice N Easy will reach out the club with the current information and withhold verification until the committee are aware of the registration and approve their involvement in the program.
5. Clubs are to generate their own coupon codes within the registration process.
6. Members are then to enter the coupon code in the "Enter a promo code" section of their checkout when purchasing from Ice N Easy.
7. The Following organisations are excluded from participation in the program.
 - a. For profit organisations
 - b. Schools
 - c. RSL Clubs
8. Ice N Easy reserves the right the refuse, reject or withdraw registration and participation in the Club Support program anytime and without notice.

How are clubs credited in the program.

10. Club credit will be attributed to the nominated active coupon codes entered at checkout
 - a. Those purchases without active coupon codes are able to email info@iceneasy.com.au with their purchase receipt and outlining the coupon code/club they would like to attribute their purchase to.
 - b. Ice N Easy will backdate any purchase from Ice N Easy in 2022 and accept the process outlined in 10a.
11. The Ice N Easy Club Support program is available to all affiliates of the specified clubs and are not confined to club members only.
12. Ice N Easy will collate a monthly report and provide to the clubs should there be any transactions with their coupon code that month.
13. A quarterly credit will be deposited into the clubs nominated account on the below date
 - Quarter 1:** Jan 1 - March 31, 2022 > Payment made April 5th, 2022
 - Quarter 2:** April 1 - June 30, 2022 > Payment made July 5th, 2022
 - Quarter 3:** July 1 - September 30, 2022 > Payment made October 4th, 2022
 - Quarter 4:** October 1 - December 31, 2022 > Payment made Jan 10th, 2022
14. A delegate from Ice N Easy will be in contact with the club delegate for the account information via a phone call once the registration has been received.
15. Should a coupon code be used that is not associated with a registered club, Ice N Easy will collate their aggregated credit and contact the club with the suggestion of registering to collect their credit.

16. Clubs must be registered to collect their credit.

General information

17. Ice N Easy reserves the right to change, suspend or terminate these terms, the program, any benefits or discounts available under the program at any time in its absolute discretion. Ice N Easy will make all reasonable efforts to communicate advanced written notice of such changes using methods including but not limited to notification on the website and an email to each delegate contact obtained through the registration process.

By participating in the program, you acknowledge and understand that Ice N Easy will use or disclose your personal and sports club information for direct marketing purposes in accordance with the Ice N Easy privacy policy (<https://www.iceneasy.com.au/privacy-policy>). Ice N Easy may contact you and the participating sports club by mail, telephone, email, SMS or social media platforms with information about Ice N Easy products and services.
19. Ice N Easy is not responsible for any government tax, duty or other charged imposed by law in any country in respect to the program, or any individual participating in the program. Any liability resulting out of or in connection with such participation is the responsibility of the individual or the participating sports club.
20. Any failure or delay by Ice N Easy in exerting its rights under these terms does not constitute a waiver of those rights. Any waiver by Ice N Easy must be in writing and signed by one of our authorised officers.
21. Except as provided in any law which cannot lawfully be excluded or modified by agreement, Ice N Easy do not accept any liability whatsoever including negligent acts or omissions with respect to the program or any goods or services supplied under the program. Any liability of Ice N Easy under statute in respect of such goods or services which cannot be excluded is limited, where permitted to supplying, or paying the cost of supplying the goods and or services of repairing or paying the cost of repair.
22. The laws of Queensland and the Commonwealth of Australia govern these Terms.

Definitions

23. In these Terms, the following words shall have the following meanings:
 - a. "The Program" means the Ice N Easy Club Support program, the credit program under which a sporting club receives a portion of the sale price for transactions made by an affiliate of their club using an active and current coupon code at checkout.
 - b. "Credit" means the amount of money the club has earned through the use of their coupon code.
 - c. "Ice N Easy" means Ice N Easy Pty Limited ABN 81 058 388 239.
 - d. "Sports Club" means Australian Sporting clubs organised for the purpose of playing sports (either individually or as a team) with a registered ABN.
 - e. "Terms" means this document and any other document referred to in it.
 - f. "website" means www.iceneasy.com.au or any other site operated on behalf of us.
